Jason Perry, trainer, agrees to take the above-listed horse into his training program and will train it to the best of his ability.

The horse owner agrees to share a complete history and expected plans for future use of this horse with the trainer

prior to the horse being dropped off for training. All bad habits, vices, prior lamenesses, or other negative or concerning attributes must be disclosed prior to drop off. If Perry Quarter Horses discovers an owner was not

In our program, we put the horse first. To do that, we have some criteria.



forthcoming with this information, we reserve the right to send the horse home and retain any paid training and board paid.

Trainer and owner will communicate on a regular basis to share updates on training and discuss expectations of training progress. After the first two weeks of training, the owner is invited to visit their horse as often as they like, by appointment only. If it is appropriate and to encourage owners to participate during their horse's training process, the owner is offered (2) 1-hour private lessons each 30 days of horse training. These lessons are to be used during each 30 days, they cannot be banked up to be used at the end of training or after the horse leaves the trainer's facility. Additional lesson time is available at regular lesson prices during training and regular lessons are encouraged after the horse leaves training.

The trainer makes no guarantees that the horse will reach the owner's expectations of talent, training, or future success.

Monthly training fees include our BUCKEYE Nutrition feed program and board. Other care including, but not limited to, hoof trims or shoes, deworming, vaccinations, hauling, showing, and veterinary care are additional. The trainer prefers all horses at Perry Quarter Horses to be maintained on our program's schedule so horses will be worked into Perry Quarter Horses schedule as needed for deworming, care of feet, etc, unless the owner objects. Care charges will be invoiced on the next 30-day invoice with receipts provided and payment is due with monthly training fees. Care will be discussed with the owner prior to care being given.

Horses are expected to be dropped off sound, healthy, and in good flesh. It is best if they are already properly dewormed, vaccinated, and freshly trimmed or shod so their training gets off to a good start. This is dependent on the time of year and age and training level of the horse.

The trainer reserves the right to send a horse back to the owner at any time during the training process. Issues and reasons will be discussed with the owner in full.

Preferred Vaccinations

- Eastern & Western Encephalomyelitis
- Rhinopneumonitis
- Influenza
- Tetanus
- West Nile
- Rabies

Owner Provided Items & Supplements

The owner may provide items for use for their horse. We encourage owners to provide a horse blanket for winter months and fly boots/sheets for summer. Trainer will "boot up" your horse for each ride to protect their legs from injury. We encourage owners to either provide a new front and hind set of high-quality orthopedic sport boots or we can bill you for new sets of Iconoclast Support Boots as our preferred brand of boots. If the horse is in training for an extended amount of time, new sets will be needed periodically.

If a blanket or fly gear is not provided the horse will not be blanketed. Horses are hard on equipment like blankets and boots; therefore, the trainer makes no guarantee provided equipment will be returned to the owner in the same condition it arrived. Please label everything!



If a horse is on supplements, please provide those to the trainer with instructions.

Payment

The fee for the first 30 days of training is due on or before the horse drop off date. Each additional 30 days training fees and all accrued care charges from the prior month are due on the first day of each training month. An invoice will be emailed 7 to 10 days prior to the start of each training month. A 5% late fee will be charged on amounts outstanding at 5 days past due. If an owner fails to pay within 20 days of the due date, a lien will be placed on the horse until all outstanding amounts are paid. If amounts are not paid within 45 days of the due date, the trainer reserves the right to sell your horse to recoup their training and care fees. All current and past amounts due are required to be paid in full prior to the horse leaving Perry Quarter Horses.

Liability

The owner understands the inherent risk of training and accepts all risk and liability including veterinary bills their horse may incur while being trained. Owners shall hold Perry Quarter Horses, its owners, trainers, and affiliates harmless of any injuries or death of their horse while in the care of Perry Quarter Horses.

The owner gives Perry Quarter Horses and its owners or affiliates permission to call for or haul to a veterinarian should they deem it necessary for the care of their horse. All efforts will be made to reach the owner for their permission to get veterinary care for their horse prior to care being given.

Reimbursement and Property Damage

If your horse is in need of medication or veterinary supplies and the trainer uses his own supply of those things, we will add reimbursement or replacement costs to the monthly invoice. The owner is welcome to buy exact replacement supplies in leu of monetary charges.

Aside from normal and customary wear and tear on saddles, other equipment, and the trainer's facility that is an accepted part of horse training, if your horse causes damage to property or the facility that cost time and expense to fix, we will ask for reimbursement. Receipts will be provided, if possible, to substantiate charges and there will be discussion about why the trainer is charging the amount.

Available Services and Rates***:

- Colt Starting & Dry Work Only Training (outside board) \$1050/30 days.
- Training using live cattle/buffalo (outside board) \$1150/30 days.
- Inside Stall Board Add \$250/30 days.

- Traveling Day Training/Coaching \$50-75/day/horse shows/clinics and other traveling with your horse in training. This is in addition to regular 30-day board/training.



- Young horse hoof trims by Jason to prepare them for a farrier \$75
- Hauling \$0.85/mile for horses in training; \$1.25 mile for non-training horses
- Farrier and Veterinary Services are available from Wilcox Farrier Services and Elite Equine of Canyon City, CO
 we pay them and provide receipts and invoice those expenses monthly on your training bill.

*** All rates and services listed are subject to change without notice – therefore some of the prices above may change while your horse is in training. However, we will honor the 30-day training rate on this signed agreement for the duration of the horse's consecutive time in training. If a horse leaves training and then returns – a new agreement needs to be signed and all current rates apply. Please do not hesitate to ask any question you have about this agreement.
